**O R D E R**

As per the Government Order cited, the conveyance, allowance to Physically Handicapped employees stands re-classified as 'Special Allowance to Physically handicapped employees' and to be drawn in Establishment pay/salary bills debiting the expenditure under 'Salaries' instead of 'Travel Expenses'. The orders have given effect from 1-4-1991.

It has now come to the notice of Government that the arrears of this allowance prior to 1-4-1991 are kept pending/deferred in certain departments for want of funds under 'Travel Expenses' and this has caused hardship to the employees. Government are therefore pleased to order that the arrears of the conveyance allowance to the Physically Handicapped employees prior to 1-4-1991 shall also be drawn in Establishment pay/salary bills by debit to 'Salaries'.
