**CIRCULAR**

Sub:- Leave Rules- Recalculation of earned leave for the first year of service of officials not in permanent employ-Ad-justment/ recovery of excess payment -clarification-reg..

Ref:- 1. Letter No. A4-5048/89 ii , dated 24-1-89 of District Collector Kozhikode  
2. Letter No. CASS (Co-ordu) I/12-28/Leave/976 dated 17-3-1989 of Account General.(Audit) Kerala, Thiruvananthapuram,

As per Rule 87 part I Kerala Services Rules, an officer not in permanent employ appointed without interruption of duty substantively to a permanent post will be credited with the earned leave which could have been admissible if his previous duty had been duty as offers in permanent employ diminished by any earned leave already taken. Now in the letter first cited it has been requested to clarify whether officiating employees who have completed three years of services are eligible for recalculation of earned leave at the rate of 1/11th for the first year of service as per the above rules.

2. It has also come to the notice of Government , that earned leave at the rate of 1/11th of duty has been calculated in the case of certain employees who have completed 3 years of service by certain Heads of Offices on the basis of certain clarifications purported to have been issued by the Accountant t General Kerala. The Accountant General as per his letter second cited has informed that no such clarification has been issued by him.

3. In the Circumstances, Government wish to clarify that no amendment/ clarification has been issued to Rule 87 part I.K.S. RS making officers who have been put in 3 years of services eligible for recalculation of earned leave at the rate of 1/11th of their period of duty.

4. All Heads of Departments/ Offices are requested to verify whether the earned leave account of any of the officers have been recalculated on mistaken notion against the above rules and if so to take immediate steps to to correct the leave accounts. The excess amount, if any, paid on this account may also be recovered forthwith.
