ORDER

The following clarificatory orders are issued in regard to the grant of non-refundable withdrawals from the Provident Funds administered by the government of Kerala.

(i) Only one non-refundable withdrawal can be allowed for the same purpose. In this context the marriage/education of different sons/daughters/relatives actually dependent on the subscriber and the illness of the subscribers or dependent on different occasions will not be treated as the same purpose. Regarding educational expenses, a withdrawal will be permitted for meeting the expenses for each year of education (of the kind mentioned in the Provident Fund Rules). Similarly a further non-refundable withdrawal can be followed for a second or subsequent marriage of the same son or daughter or relative actually dependent on the subscriber. In the case of marriage, the amount should not be drawn earlier than three months of the date of marriage and if for any reason the marriage is postponed beyond 3 months from the date of drawal of the amount, it should be refunded. In such cases a fresh withdrawal can be allowed when the need actually arises.

(ii) A temporary advance and a non-refundable withdrawal for the same purpose should not be granted together. Further the temporary advance which is subsequently converted in to a non-refundable withdrawal should be treated as a non-refundable withdrawal and in such cases another non-refundable withdrawal should not be granted for the same purpose.

(iii) A person who has been granted a non-refundable withdrawal should not be permitted to convert a temporary advance taken for the same purpose into a non-refundable withdrawal.
