## ORDER

According to the orders issued in the G.O. read as first paper above, a provisional hand appointed through the employment Exchange can be continued in service till a nominee of the Public Service Commission is appointed or the Commission have declined to accord concurrence to the appointment, provided that the concurrence of the Commission is taken for the continuance of the provisional hand beyond three months. This procedure will not also stand in the way of throwing out temporary hands at the end of the academic year in schools and other institutions where there is authorised vacation and re-appointing them after re-opening of the schools/ institutions after the vacation provided the vacancies continue. It has now been brought to the notice of the Government that the above orders stand in the way of implementing the orders in the G.O. read as second paper above in as much as provisional hands appointed against posts in the Last Grade Service which have been reserved for promotion from the part-time contingent employees, cannot be discharged from service since the Part-time contingent employees cannot be deemed to be nominees of the Public Service Commission.

- 2. Government have examined the question and are pleased to order, in modification of the G.O. read as first paper above, that the provisional hands appointed through the Employment Exchange against posts in the Last Grade Service which have been reserved for promotion from the part time contingent employees, as per the G.O. second cited, be discharged from service in order to give promotion to the part-time contingent employees as provided in the G.O. second cited.
  - 3. The above amendment shall be deemed to have come into force with effect from 15-12-1971.
