ORDER

In the G.O. read as second paper it was ordered that the promotions given to members of Scheduled Caste/Scheduled Tribes in service by virtue of temporary exemption from passing Departmental tests will be regularized with effect from the dates of their first promotion on provisional basis if the persons concerned pass the required tests within the period of temporary exemption. In the letter read as third paper above, General secretary, Dr. Ambedkar Memorial Harijan Seva Sanghom, Malappuram District has represented that certain heads of Departments hold the view that the above G.O. is applicable only to those who have been promoted on or after 13-1-1972, the date of the G.O. first cited and not to those who were allowed such exemption before that date. He has stated that this stand is not in accordance with the intention of the G.O. and has requested that a clarification may be issued stating that the G.O. second cited is applicable also to persons belonging to Scheduled Castes and Scheduled Tribes in service who were promoted by virtue of temporary exemption granted before 13-1-1972.

Government have examined the request of the Sanghom, Under General rule 13A as it stood prior to and after its amendment to G.O. (P) 203/74/PD dated 21-8-1974, temporary exemption for specified period is available to all persons in service (including members of Scheduled Castes and Scheduled Tribes) when a special departmental test os newly prescribed. The general princips is that a person who is temporarily promoted by virtue of temporary exemption from passing the prescribed tests, is to be given regular appointment with effect from the date of such first promotion if he acquires the test qualification within the period of temporary exemption. Government are pleased to clarify that the above principle will apply in regularizing the temporary promotions given

to any person (including members of the Scheduled Castes and Scheduled Tribes) by virtue of temporary exemption from passing Departmental tests under Genral rule 13A or any other rule or order.
