ORDER

Government are pleased to order that the procedure prescribed in the G.O. read as first paper, as subsequently amended for dealing with requests for appointment from relatives/ dependents of Government servants dying in harness, will be modified as follows:-

(1) The minimum period of service to be put in by an employee so as to render his dependents eligible for appointment in Government service under the dying in Harness Scheme will be reduced from 10 years to 5 years.

(2) The maximum annual income limit of the family of the applicant for eligibility for appointment under the scheme will be enhanced from Rs. 4,200 to Rs. 6,000 (Rupees six thousand only) exclusive of the family pension. This enhanced income limit will be

applicable to all cases where applications could legitimately be made on or after 16-1-1979.

(3) Married son of a deceased Government Servant will be treated as dependent for extending the benefit of the scheme.

(4) Appointment under the scheme will be restricted to posts in subordinate services.
