ORDER

According to the orders issued in G.O. read as first paper , persons appointed to posts under the State Government, whether by direct recruitment , by transfer or by promotion, irrespective of whether the appointments were made in consultation with the Kerala Public Service Commission or not, where such consultation is necessary, shall be allowed to draw their increment in the posts to which they are appointed, although the appointments a treated as provisional or having been made under the emergency provisions. In the G.O. second read above, it was clarified that as long as the orders issued in G.O.read as first paper continues to be in force, increments shall be allowed to all persons holding appointments under the emergency provisions, irrespective of the fact whether or not they posses the prescribed qualifications and their services are likely to be regularized, provided they are other wise eligible to draw such increments.

In the G.O. read as third paper, Government clarified that the above concession was granted in view of the difficulties being experienced by the provisional hands for no fault of theirs and that the concession will be available only for a period of two years from 9-7-1980.

It has been brought to the notice of Government that regularisations appointments of many are delayed on account of the delay in the issuance of special rules, or disputes in the seniority lists consequent on the stay orders of the high Court of an account of non issue of select lists by the Departmental Promotion Committees etc. Since the enforcement of the order contained in G.O. dt. 9-7-80 will cause hardships to a large number of such employees in service under various Departments, Government are pleased to order that the implementation of the Government order dated 9-7-1980 be kept in abeyance till 9-7-1984.

All Heads of Departments will take immediate action to regularise the provisional appointments/ promotions with in the above period, by finalizing the special rules or the seniority lists holding the meeting of the Departmental promotion Committee, as the case may be . The above time limit will not be extended further and the Heads of Departments will be personally held responsible for the delay in regularization of he provisional appointments/ promotions in their Departments.
