Public services re-employment of demobilized defiance personnel on a priority basis preferential treatment to ex-servicemen for appointment as foresters and guards orders issued.

The Government of India have pointed out that released defence force personnel by virtue of their training would be eminently suited for appointment to certain posts involving security functions and requiring proficiency in the use of fire arms such as police, Home guard etc. They have therefore suggested that other things being equal ex-servicemen may be given preference over others for appointment to such posts.

The chief conservator of Forests has suggested that preference may be given to ex-servicemen for appointment as guards and foresters provided they possess the matter in qualifications.

Government have examined the matter in consultation with the public service commission and are pleased to order that subject to other rules and conditions being satisfied , preference will be given to ex-servicemen for direct recruitment to the posts of foresters and forest guards grade I I the forests department and to the post of II grade guards in the wild life department.

A notification containing necessary amendment to the Kerala Forest subordinate service special rules is enclosed. The Superintendent of Government presses will publish the notification in the next issue of the gazette and supply 50 copies of the notification to the Agriculture (Forest Establishment) Department and 150 copies to the Chief Conservator of Forests.

## NOTIFICATION

In exercise of the powers conferred by the Proviso to Article 309 of the constitution of India the Governor of Kerala hereby makes the following amendment to the Kerala Forest subordinate Service (Special Rules Published in the Kerala Gazette No 1 dated 1st January, 1963.

## AMENDMENT

In rule 6 of the said rules

1. After item (2) in column (3) of the table against entry (foresters in column (1) following note shall be added namely.

“Note subject to other rules and conditions being satisfied performance shall be given to ex-servicemen for direct recruitment.

2. After item (2) in column (3) of the table against entry ‘Forest guards II grade’ in column(1) the following note shall be added namely.

“Note subject to other rules and conditions being satisfying preference shall be given to ex servicemen for direct recruitment.
