# ORDER

Sri T. Achutha Poduval, Forest Guard while working in Trichur Division entered on leave from 28.10.1959 on sick grounds and was continuing as such up to 27.10.64. He has submitted a petition to the Divisional Forest Officer, Trichur on 30.12.64 requesting that he may be permitted to retire on invalid grounds. He was therefore directed in November 1965 to produce a Medical Certificate. A Medical Certificate was produced after three years. When the Pension papers were forwarded to the Accountant General he did not accept the Medical Certificate and directed to produce a Medical Certificate as per rules 51-54, Part III, Accountant General along with a Medical Certificate issued by the District Medical Officer, Trichur on 3.2.71. Then the Accountant General has instructed to obtain Government Orders to regularize the retirement of Sri. Poduval on 28.10.64 without production of Medical Certificate relaxing Rule 51, Part III, Kerala Service Rules, Since it will not be Possible to obtain a Medical Certificate dated 28.10.64.

In the circumstances or the case as explained by the Chief Conservator of Forests above Government are pleased to order that the retirement of Sri. Achutha Poduval, Forest Guard from 28.10.1964 is reguled without production of Medical Certificate in relaxation of Rule 51, Part III, and Kerala Service Rules.
