S.R.O. No.978/78- In exercise of the powers conferred by sub section (1) of section 2 of the Kerala Public Service Act, 1968 (19 of 1968), read with section 3 thereof, the Government of Kerala hereby made the following amendments to Kerala Service Rules, namely:-

AMENDMENT

C.S.. NO. 349/78/Fin.

In Part II of the said rules, the rule 99A, condition (iii) shall be numbered conditions (iv) and-

(i) In condition (iv) as so numbered, for the words “within two months of retirement” the words “within two months of the date of drawal of the advance” shall be substituted:

(ii) before conditions (iv)as so renumbered, the following conditions shall be inserted, namely:-

“(iii) The journey shall be performed within one year of the date of retirement”.

Explanatory Note

(This is not parts of the amendment, but is intended to indicate the general purport.)

According to the existing rules in Kerala Service Rules there is not time limit for performing the journey after retirement. It is considered necessary to fix a time limit for the purpose a provided in the Central rules. Where a time limit is so fixed there is not meaning in saying that the detailed Travelling Allowance bill should be presented within the two months of the date of retirement. Hence the above amendments to the rules.
