### O R D E R

As per the read as 1<sup>st</sup> paper above, application forms dates applying for the posts nor filed by the Kerala Public Service Commission. It was also ordered there in that a model application form will be published by the Kerala Public Service Commission along with the notification for the posts and the application will prefer their applications in the said model form wither typed or printed. Accordingly in the short notifications published by the Kerala Public Service Commission in news papers the model form is also being published.

Government have examined in consultation with the Kerala Public Service Commission the question of dispensing with the practice of publishing the model applications from along with the short notifications published by the Kerala Public Commission in news papers, and are pleased to order as follows:

1.Model application form will not be published by the Kerala public Service Commission here after along with the short notification published in news papers inviting applications for various posts. However before dispensing with the system for the information of the Public/ Interested persons, the odel application from will be published once in all the news papers in which the Kerala Public Service Commission notification published. The cut outs from News papers should not be used to prefer applications in the model from either typed or printed in white paper.

2.The model application form will continue to be published in the Kerala Gazette along with the notifications of the Kerala Public Service Commission.

3.Specimen application form will be exhibited in the office of the Kerala

Public Service Commission. (including District Office of the Commission) in all panchayath/ Municipal/ Corporation Offices and in District information Offices for information. The specimen application forms require for this purpose will be made available the concerned authorities by the Kerala Public Service Commission.

4. In cases where annexure are required to be appending will the application form, the specimen of such annexure will be published in news papers. Similarly the model of the application for when changed will also be published in the newspapers, for information's.
