In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India and of all powers hereunto enabling, the Governor of Kerala hereby makes the following further amendments to the Kerala State and Subordinate Services Rules, 1958, namely;-

(iii ) after item 57 A, the following item shall be inserted, namely;-

‘ 57-B. Reddiars (through out the State except Malabar District )’

(iv) for the item “70, Veerasavias (Yogis) the following item shall be substituted, namely;-

“70./Veerasavias (Yogis and Yogeeswra)’

(c )The following explanation shall be inserted at the end, namely;-

“*Explanation*;- In this Schedule, Malabar District shall mean the Malabar District referred to in sub –section (2) of the States Re organisation Act, 1956”.

2. In Part II-

after sub- rule (e) of rule 35, the following sub-rule shall be added, namely;-

(f ) Notwithstanding any thing contained in these rules or in the Special Rules, in the case of persons allotted to the State of Kerala from Service under the Government of Madras consequent on the Re- organization of states, pass in Account Test for Executive Officers (Madras) and pass in Account Test for Subordinate Officers, Part 1 (Madras ) shall respectively be accepted as sufficient qualification in lieu of pass in Account Test for Executive Officers of the Kerala State and pass in Account Test (lower)”
