NOTIFICATION

S.R.O. No. 505/77-In exercise of the powers conferred by subsection (I) of section 2 of the Kerala Public Services Act, 1968 (19 of 1968) read with section 3 thereof the Government of Kerala hereby make the following amendment to the Kerala Public Services Rules, 1958, namely:-

AMENDMENT

In Part II of the said Rules, in rule 9, to sub-rule (e) the following note shall be added, namely:-

Note:-For the purpose of reckoning the period of two years continuous service prescribed in this sub-rule, the period during which a person continued in service, after the date of receipt by him of the order of the competent authority terminating his services, by virtue of any order of court staying such order of termination, shall not be taken into account unless such order of termination, has been finally quashed by the Court.”

This amendment shall be deemed to have come into force with effect from 16-01-1974.

Explanatory Note

(This note is not part of the notification, but is intended to indicate its general property).

General Rule 9 (e) of the Kerala State and Subordinate Service Rules, 1958 lays down that notwithstanding anything contained in those rules the Government may by order regularize the services of any persons appointed under Rule 9 (a) (i) of the said rules, provided that such person shall have two years continuous service on 22-12-1973. A question has been raised as to whether the provisional (temporary) service rendered by the provisional (temporary) hands by virtue of stay orders of the High Court will be taken

into account for the purpose of reckoning the two years' continuous provisional (temporary) service on 22-12-1973 prescribed for eligibility for regularization. Government have decided to make the position clear by adding a note to General Rule 9 (c). This notification is intended to achieve the above object.
