S.R.O No164/78- In exercise of the powers conferred by subsection (i) of section 2 of the Kerala public service act 1968 (I of 1968) read with section 3 thereof the Government of Kerala hereby make the following amendment to the Kerala state and subordinate services rules 1958 namely;

AMENDMENT

In part II of the said rules in the note to rule 13b after the words “Military Service” the following shall be inserted namely;-

“and service rendered in aided schools local bodies and Universities work establishment service of full time work establishment employees absorbed into Government service or recruited by the public service commission, private college service to the credit of teachers of Government college”

Explanatory Note

(This note is not part of the amendment, but it is intended to indicate its general purport)

It is necessary to give statutory validity to the orders in G.O.(P) No 147/71/PD dated 23-12-1971 according to which service rendered in aided schools, local bodies and universities and work establishment service of the full time work establishment employees absorbed into Government service and of the full time work establishment employees recruited by the public service commission shall also be counted for reckoning the minimum period of service of 25 years prescribed in rule 133 in part II (general rules) of the Kerala state & subordinate service rules 1958 for eligibility for permanent exemption on form passing obligatory departmental tests. It is also considered necessary to reckon the private college service if any available to the credit of the teachers of the government colleges for the above purpose.

This notification is intended to achieve the above object.
