NOTIFICATION

S.R.O.No 90/80- In exercise of the powers conferred by subsection (1) of section 2 of the kerala public services act 1968 (19 of 1968) read with section 3 thereof the government of kerala hereby make the following amendment to the kerala state and subordinate services rules 1958, namely;-

AMENDMENT

1. (1) This rules may be called the kerala state and subordinate services (amendment) rules,1979.

(2) they shall come into force at once.

2. In part II of the kerala state and subordinate service rule 1958in rule 4 for the second provision the following provision shall be substituted namely;-

“provided further that a candidate who is an ex- serviceman and who is in receipt of pensionary benefits for his military service may also make his application for appointment to posts in subordinate services in a form with only ¼ th amount of the prescribed fee embossed thereon.”

Explanatory Note

(This note does not form part of the notification but is intended to indicate its general purport.)

According to rule 4 of the General Rules an ex-servicemen related after completion of normal tenure of service from the defense forces make his application for appointment to posts in the subordinate service in forms of value of prescribed fee. Subsequently as advised by the PSC in G O(MS) No

250/79/GA dated 10-4-1979 it was ordered that the above concession might be restricted to ex serviceman who were in receipt pensionary benefits or were eligible for pensionary benefits for their military service Rule 4 of the General Rules has therefore to be amended accordingly.
