**NOTIFICATION**

**S.R.O.No. 122/81** – In exercise of the powers conferred by sub section (1) of section 2 of the Kerala Public Services Act, 1968 (19 of 1968), the Government of Kerala hereby make the following amendment to the Special Rules for the Kerala Part-time Contingent Service published under notification No. G.O. (P) 152/75/PD dated the 2<sup>nd</sup> August, 1975 as S.R.O.No. 742/75 in Part I of the Kerala Gazette No. 34 dated the 29<sup>th</sup> September, 1975 as subsequently amended, namely:-

**AMENDMENT**

In the said Rules, in rule 14, in clause (c), for the first sentence, the following shall be substituted, namely:-

“Maternity leave for three months to female employees with full pay Dearness Allowance for the period.”

This amendment shall be deemed to have come into force with effect from the 31<sup>st</sup> March, 1980

**EXPLANATORY NOTE**

(This note is not part of the notification but is intended to indicate its general purport)

In G.O.(P) No. 742/81/(240)/Fin. Dated 9-10-1980, Government issued executive orders allowing female part-time contingent employees maternity leave for 3 months with full Pay and D.A. with effect from 31-3-1980. This has necessitated amendment to Rule 14 of the Special Rules for the Kerala Part-time Contingent Service. This notification is intended to achieve the above object.
