NOTIFICATION

S.R.O.No. 402/82:- In exercise of the powers conferred by subsection (1) of section 2 of the Kerala Public Services Act, 1968 (19 of 1968), the Government of Kerala hereby make the following amendment to the Special Rules for the Kerala Part-time Contingent Service Published under Notification G.O. (P) No. 152/75/PD dated the 2nd August, 1975, as S.R.O.No. 742/75/, in Part I of the Kerala Gazette No. 34 dated the 2nd September, 1975, as subsequently amended, namely:-

AMENDMENT

In the said rules, in rule 3, the existing Note shall be numbered as 'Note 2' and before Note 2 as so numbered, the following Note Shall be inserted, namely:-

“Note 1:- There per cent reservation shall be allowed to the physically handicapped persons for appointment to the various categories. The appointing authority shall however satisfy himself that the duties attached appointing authority shall however satisfy himself that the duties attached to the relevant category can be performed by a physically handicapped person”

This amendment shall be deemed to have come into force with effect from the 31st December, 1981.

Explanatory Note

(This note is not part of the notification but is intended to indicate its general purport)

In G.O. (Ms) No. 436/84/GAD dated 31-12-1981, it was ordered that three percent reservation shall be allowed to the physically handicapped persons for appointment through Employment Exchange to the Part- Time contingent posts and that the appointing authorities should satisfy themselves that the duties attached to the post can be performed by the physically handicapped persons so appointed. This has necessitated amendment to the Special Rules for the Kerala Part-time Contingent Service. This notification is intended to achieve the above object.
