ORDER

In the G.O. Ms. No. 338/81/GAD. dated 3-10-1981 it was ordered that 2% of the vacancies arising in the cadre of Assistant Grade II in the Secretariat, Offices of the Public Service Commission and the Advocate General and the cadre of Grade II Auditor in the Office of the Examiner of Local Fund Accountant be reserved for persons holding low paid posts (included in the Subordinate Service) with four years aggregate service in their respective category of post, having the minimum educational qualification prescribed for appointment to the post by direct recruitment and who secure not less than 40% marks in the competitive test conducted by the Public Service Commission. It was also ordered that the Commission should maintain a separate ranked list of such persons and candidates from this list would be advised against the 2% vacancies set apart for them and they should take their chances purely on the basis of merit and be conserved against open competition vacancies and not against turn reserved for particular communities. In case there are no candidates to fill up the 2% reservation stated above, such vacancies would be filled up by direct recruitment.

2. Government, after consultation with the Kerala Public Service Commission, order that the Commission will prepare a separate ranked list of the low paid employees eligible for 2% reservation for appointment as Assistant Gr. II in the Secretariat, in the Office of the Public Service Commission and Advocate General and Grade II Auditor in the office of the Examiner of Local Fund Accounts and advise them in the 26th and 76th vacancies without observing the procedure in the first Service Rules 15 (c) of the General Rules of Kerala State & Subordinate Service Rules, 1958 regarding 50% rule as the advice has to be made out of rotation.
