

**PROCEEDINGS OF THE PRINCIPAL CHIEF CONSERVATOR OF FORESTS,  
TRIVANDRUM.**

***PRESENT: - SHRI.M. SIVARAJAN, I.F.S***

*Sub:-* Forest Department- Establishment – Appointment of vacancies of Rangers  
That arose from 31-10-79 to 1-1-1987- Orders issued.

*Read:-* Proceedings No E7.48163/84 dt: 26-8-1985.

**Order No.E1.2263/87 dt: 16-3-87**

In this office proceedings read above, a combined final seniority list of Rangers in the Forest department was published duly assigning the vacancies that arose in the category of Rangers from 1-11-1956 to 30-10-1979 among the different feeder categories, viz.DR/FA, TIR, FNTR and MSTR as laid down in Special rules. According the above seniority list, the vacancies that arose in the category of Rangers up to 30-10-1979 were taken in to account for apportioning and assigning the vacancies as detailed below:

2. The last person to whom the vacancy assigned under ‘Erstwhile wildlife Department’ is Shri.K.G.Pameswaran (vide sl.No.71 of the seniority list read above). The date assigned to him is 1-11-1961 there is no further appointment under this category.

3. The last person to whom the vacancy assigned under the category ‘MSTR’ is shri. M.V. Kuruvila (vide Sl.No 52 of the said seniority list) The date of assignment is 22.8.1960. there is no appointment under this category.

4. The last person to whom the vacancy assigned under the category ‘ENTR’ id shri.K.Balakrishnan Nambiar (vide Sl.No 366-b of the said seniority list) The date of assignment of vacancy to him is 30-10-1979 even though he was provisionally promoted on 7-12-1973. After the provisional promotion of Shri. Nambiar on 7-12-1973, 123 provisional promotions are given to the person in the category of ‘FNTR’. These 123 provisional promotions have not been regularized.

5. The last person to whom the vacancy assigned under the feeder category ‘FTR’ is shri.K.A. Noorudheen Mather (vide sl.No.353 of the said seniority list). After the appointment of Shri. Mather as Ranger on 30-3-1983, twenty FTR’s, were appointed as Rangers through Public Service Commission Selected.

6. The last person to whom the vacancy assigned under the feeder category “FA” is Shri. P. Chandrabhanu Panikar (vide Sl.No.364 of the said seniority list) His date of assignment is 30-10-1979. After the appointment of Shri. Panikar on 1-11-1983, forty-one FA’s. were appointed as Rangers through Public Service Commission.

7. The date of the provisional promotion given to the last person under the feeder category “FNTR”, shri. K. Balakrishnan Nambiar as per the seniority list read as above was 7-12-1973. The date of regularisation of his provisional promotion according to the Special Rules was on 30-10-1979 (vide Sl.No 366 of the seniority list) after the date of provisional promotion Shri.N.Balakrishnan Nambiar, 123 FNTR were also provisionally of General rules. These provisional promotions have also to be regularized in accordance with the ratio fixed in the Special Rules. During the period from 31-10-1979 to 1-1-1987 there arose 184 vacancies of Rangers in Forest Department. These vacancies are apportioned as detailed below as per the ratio fixed in the Special Rules.
