ORDER

In his letter read above. The Chief Conservator of Forests has reported that in spite of two tender notifications for the work referred to, there was no response and the Divl. Forest officer, Trichur has been directed to take up the work departmentally in accordance with the rates provided in the estimate for Rs. 22,490/- (Twenty two thousand four hundred and ninety nine only) forwarded by the Divl. Forest Officer, Trichur. As the rates for items 2, 4 and 7 of the estimate, extracted below are not in conformity with the sanctioned schedule of rates the Chief Conservator of Forests has requested Govt. to ratify his action in having directed the Divl. Forest Officer, Trichur to take up the work departmentally at the enhanced rates provided for items 2,4 and 7 of the estimate extracted below on the ground that these rates are essential to carryout the work under the prevailing circumstances and these rates were sanctioned by Govt. during 1969-70 and 1970-71 vide G.O.(Rt.)P719/69/Agri. Dated 10-3-69 and G.O.(Rt.) 2991/70/AD dated 10-11-1970 respectively.
