Sub:- Presentation of logs for selection at Veettur Depot and transport of selected logs to Ernakulam Depot and stacking the logs at Ernakulam Depot - during 1973-74.

Tenders were invited to be received on 23-8-'73 by the Divl. Forest Officer, Hydel Divn., Kottayam for the following works.

The tender notice was published in Gazette dt. 31-7-'73, para 387 of the Forest Shoots and in dailies "Deepika", Kottayam dt. 10-8-'73 and 'Kerala Times', Ernakulam dt. 10-8-'73. The tenders were received on 23-8-'73.

7 (seven) persons presented tenders for the work and the rates offered by the tenderers are noted below:

It may be seen from the above that two of them (Items 3 & 5) have quoted the same rate, ie., 77% which is also the lowest rate. It is requested by the Divl. Forest Officer the Kolevila rate was auctioned between these two tenderers. Sri. T.A. Syed Mohammed (item No. 5) was not willing to take up the work, at any reduced rate. Sri. V.M. Suleiman (Item No. 3) agreed to reduce the rate by 1% and therefore, the UCTION WAS KNOCKED DOWN IN THE NAME OF Sri. U.M. Sulaiman @76% of the standard rate.

The Divl. Forest Officer has reported that there was been competition among the tenderers. The rate offered by Shri. U.M. Sulaiman at 76% the departmental standard rate is the lowest. The Divl. Forest Officer has recommended that the offer of Sri. U.M.Sulaiman may be accepted. Under the circumstances, reported, and having convinced that there has been adequate publicity and the rate offered is reasonable, I, Shri. K.C. Vasudevan, Conservator of Forests, Central Circle, Trichur hereby ACCEPT the tender of Sri. U.M.Sulaiman, Uppottil, Mudical, Perumbavoor who has offered the rate of 76% of the departmental rate and the work is awarded in his name.

The Divisional Forest Officer will pursue further action for execution of agreement. The revised estimate for the above work is sanctioned for Rs. 77562/- as per Ch. 48/M/73-74 and copy of the estimate is also forwarded. Seven Tenders in original are returned herewith.
