ORDER

Government have accorded sanction for revision of seigniorage rate of timber and other forest produces for 2007 -2008 and 2008 - 2009 as per the Government Order read as above.

It has been brought into the notice of Government by Chief Conservator of Forests (Protection) vide his letter read as 2nd above that repetition of rates have been crept in respect of certain species having different local names in different localities in the State and scientific names of certain species are not provided against its local name.

Chief Conservator of Forests (Protection) has therefore requested Government for deleting such serial numbers having repetition of rates and no scientific names from the Annexure to Government Order read above.

Government therefore order that the following serial numbers having repetition of rate and no scientific names will be deleted from the Annexure to G.O (MS) No. 15/2010/F&WLD dated 3-5-2010.


