ORDER

In the letter read above as first paper (copy of which was enclosed with the G.O. read as fifth paper) the Government of India addressed all the State Government on the question of reciprocal arrangements between the Union Government and also between the state Governments inter-so whereby one Government may not prefer against another any isolated claim for an amount not exceeding Rs.1,000/-. This government have agreed to the reciprocal arrangement with the Government of India and the decision was conveyed to them in the letter read as second paper above. In determining whether a particular claim is covered by the reciprocal arrangement mentioned above, the criterion will be that the claim should be both petty and of an occasional character and should cover services rendered and not supplies made unless the letter forms part of service.

2. All the State Government were addressed in the letter third cited to ascertain whether they were agreeable to have such a reciprocal arrangement with this Government and in the G.O. read as fourth paper this Government have communicated their acceptance to the arrangements to the Government have communicated their acceptance to the arrangements to the Government of Assam, Jammu and –Kashmir, Madras, Maharashtra, Gujarat, Rajasthan, Pun jab, Bihar and Andhra Pradesh, who had agreed to the proposal.

3. In the G.O. read as sixth paper the Government of Mysore have issued orders accepting the inter-state arrangement with the Government of West Bengal who had also agreed to the proposal.

4. In the G.O. read as sixth paper the Government of Mysore have issued orders accepting the inter-State Arrangement with this Government to be effective from 2-7-1962 till 31-3-1966.

5. In the circumstances the Government order that the inter-state arrangement along the lines indicated by the Government of India will be effective between the Governments of Kerala and Mysore from 2-7-1962 till 31-3-1966.

The arrangement may be extended beyond that date by mutual agreement.
