ORDER

Certain Forest lands have been leased out to Plantation Corporation of Kerala for the purpose of cultivating rubber or any other plantation crops which the lessee under their Memorandum of Association is empowered to cultivate. The Corporation has the undertaken cultivation of Cashew in the area unsuitable for Rubber. The Plantation Corporation requested Government that sanction might be accorded to them for subleasing the area unsuitable for Rubber Cultivation of Taungya Cultivation wherever it could be undertaken. In the G.O read as 1st paper above sanction was accorded permitting the plantation corporation has planted cashew, for Taungya Cultivation subject to the following terms and conditions:-

- (i) The Plantation Corporation of Kerala will remit to the credit of the Forest Department 50% of the profit that may be derived by the plantation corporation of Kerala by subleasing the area for taungya cultivation.
- (ii) The sub lease period should in no case exceed one season at a time.
- 2. The Managing Director, Plantation Corporation of Kerala in his letter read as 2nd paper above has requested to Government to waive the condition No.(i) regarding the remittance of 50% of revenue and to accord sanction to sublease the area for 3 season instead of one season as already sanctioned.
- 3. Having considered the requests of the Corporation, the Government are pleased to order that condition (i) in the G.O. be delected and condition (ii) be modified is follows- the sub-lease period should in no case exceed three seasons".
- 4. In view of the above the instructions in para 2 of the G.O. read above need not be carried out by the Chief Conservator of Forests.
