NOTE

In the subject II Committee meeting held on 25-6-81 Sri. Sreenivasan, MLA., Punalur raised the objection that earlier meeting it was decided to review the plantation programme of Eucalyptus by Forest Department and further plantation of eucalyptus should be stopped till this is done. His strong objection is in the conversion of some evergreens in Punalur Division (Pathanapuram range) for raising a huge shunk of Eucalyptus plantations, ever there. It was explained that this is KFDC. Operation based on Government decision. Local people have also started agitation with a demand to stop planting Eucalyptus for plantation crops like Rubber.

Action may be taken to appraise MD., KFDC on this issue.

Action may also be taken by statistical wing to collect full details on cashew plantation asked for by the Committee.
