ORDER

The proposal for dispensing with the system in which certain categories of N.G.Os, who draw their pay and other entitlements in Gazetted Officers of Government for some time past, since the claims of these category of officers escape the control over expenditure by way of authorization slip from the Accountant General and Treasury bill book in the case of Gazetted a Officers and N.G.Os. respectively.

Accountant General, Director of Treasuries and P & A.R. Department have been consulted on this issue and it is proposed to introduce the following procedures for the drawal of pay and allowances and other claims of those categories of non-gazetted officers, such as Co-operative Inspectors of the Co-operative Department, Sub Inspectors of Police etc. who are at present following their Pay and Allowances and other claims in the Gazetted officers bill forms with or without countersignature of the controlling officers, so as to guard against fraudulent claims.

Having examined the question in detail, the Government are pleased to order as follows:-

- (i) In the case of Officers who have a separate establishment of their own, their claims will be drawn in their establishment pay bills.
- (ii) In the case of officers who have no separate establishment of their own, like Co-operative Inspectors of Co-operative Department, such officers will be attached to the office of their controlling officers who are at present countersigning their bills.
- (iii) In Police Department, pay and allowances of Policemen and Sub Inspectors will be drawn and disbursed by the concerned Superintendent of Police.

The revised procedure will take effect from 1-5-1986.
