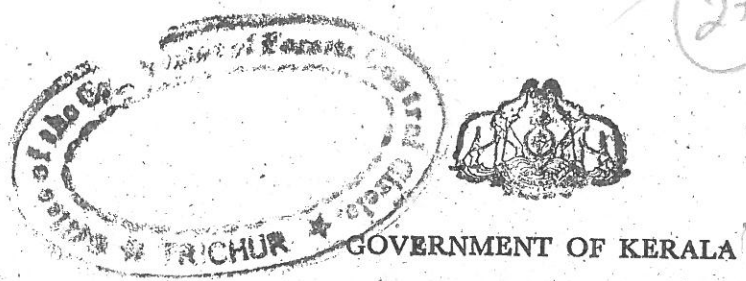

No. 86/90/Fin. Thiruvananthapuram, 28th December 1990.

Sub :—Deputation to Foreign Service—Details furnishing of—Further instructions—Issued.

- Ref :—1. G.O. (P) 250/83/Fin. dated 11-5-1983.
 2. Letter No. PCI/Genl./432/1175 dated 11-10-1990 from the Accountant General, Kerala.

In the G.O. read as, first paper, it was ordered that the Head of Office should furnish the date of relief of the employee, date of joining in foreign service, pay scale, subsequent changes in pay, promotion, pay revision etc. in respect of deputationists, to the Accountant General. In the letter read as 2nd paper, the Accountant General has reported that the above details are not being made available in most of the cases. This has resulted in delay in the recovery of leave salary and pension contributions from the foreign employers.

2. Government do hereby instruct that the scale of pay of the officer who is ordered to be sent on foreign service shall be furnished invariably in the orders sanctioning the deputation and a statement duly filled in as required in the Government decision below Rule 144 of Kerala Service Rules shall be attached along with the sanction orders.

3. All Heads of Departments should also forward a list of officers who are on deputation, stating the scale of pay and the office to which they have been deputed, the date from which the deputation was sanctioned and the period of deputation, to the Accountant General (A & E), Kerala, immediately.
