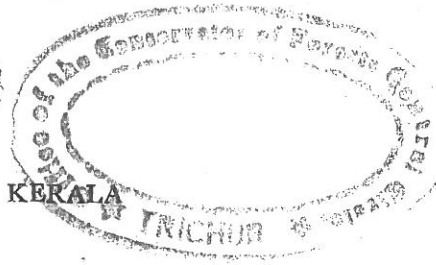

ORDER

As per the G.O's read above, Government have accorded sanction for the reimbursement of Autorickshaw/Taxi charges for official journey from residence or office to Airport/Railway Station/Bus Station and back at the rates fixed from time to time. Several departmental officers have sought clarification on the admissibility of such claims and Government issue the following clarifications for compliance with immediate effect.

- (i) Autorickshaw/Taxi fare at the rates fixed by Government from time to time will be reimbursed subject to a maximum distance of 8 kms. The Hire charges fixed by Government in the Public Works and Transport Department from time to time will be applicable for reimbursement for this purpose.
- (ii) The Autorickshaw/Taxi fare will be admissible for onward journeys from Railway Station/Airport/Bus station at the outstation, to the place of halt of the officer/office.
- (iii) Autorickshaw/Taxi charges will not be paid for other local trips undertaken during such halts in outstations.
- (iv) For return journey also, Autorickshaw/Taxi fare will be admissible from the place of halt/office to the Airport/Railway station/Bus station.

- (v) Reimbursement of such charges from Airport/Railway Station/Bus Station on return to resident/office on completion of official journey will also be restricted upto 8 kms.
