ORDER

As per the Government orders read above, all the Heads of Departments, Drawing and Disbursing Officers (DDO's), Gazetted Officers and Treasury Officers were authorised to recover dues in respect of the chitties, hire purchase business and other schemes of the KSFE Ltd., from the salary of the employees including Gazetted Officers of Government, Local Bodies, quasi-government institutions, Private Schools and Colleges who are subscribers/hirers/sureties.

Now, the Managing Director, Kerala State Financial Enterprises has brought to the notice of Government that certain DDO's are not deducting the amount due to the company from the salary bills of the employees concerned and nthis has resulted in accumulation of huge arrears. He has, therefore, requested Government to issue instructions for strict compliance of orders in force and making it obligatory on the part of DDO's to effect recovery from the defaulters.

Government have examined the matter and are pleased to order that all the Heads of Departments, DDO's, Gazetted Officers and Treasury Officers will strictly adhere to the instructions already issued by Government from time to time and ensure that recovered are effected from defaulters to KSFE without fail. If there is wilful default in recovery, the DDO 's/Gazetted Officers concerned all be personally held responsible.

These instructions shall be applicable to all persons employed in Government departments and other quasi government Public under takings, Local bodies, private schools and colleges.

The Director of Treasuries will instruct all Treasury Officers to ensure that dues to KSFE are got deducted from the salary bills of defaulters as per the advice of the KSFE Ltd.
