Forest Conservation Act- Forest Clearance- Diversion of 0.0619 ha. of Forest land in Thalapilly Taluk to the public works Department for construction of an approach road of railway overbridge - Valloor Feeder Road - Thrissur District - Sanction accorded - Orders issued.

ORDER

The Chief Conservator of Forests in his letter read as first paper above has proposed to divert 0.0619 ha. of forest land in Thekkunkara Village in Thalapilly Taluk in Thrissur District to Public Works Department for construction of an approach road of Railway overbridge at 19.01 of Thrissur and Shornur (Valloor Feeder Road). Government of India in their letter read as second paper above have accorded sanction under Forest Conservation Act for the above proposal.

In the above circumstances sanction is accorded for the diversion of 0.0619 ha. of forest land in Survey Nos. 900 and 1403 of Thekkunkara Village in Thalappilly Taluk, Thrissur District for the above purpose subject to the following conditions.

- a) The legal status of the forest land will remain unchanged.
 - b) The total forest area utilised for the construction of approach road shall not exceed 0.0619 ha.
 - c) The lease is for a period of 10 years.
 - d) Proposals for renewal of lease shall be submitted six months before expiry of lease period.
 - e) 10 trees shall be planted for every tree felled. However, the minimum number of trees to be so planted shall be computed at the rates of 2500 trees per ha. for the forest area being actually diverted, as per the guidelines of the Government of India vide letter No. 2-1/90-FC, dated 3.2.1990.

The Chief Conservator of Forests will take further necessary action in the matter.
