ORDER

As per the Government order read as first paper above the seigniorage rates of Timber, Firewood and other Forest Produces was revised for the year 1984-85. In the Government order read as second paper above it was ordered that the seigniorage rates ordered in the Government order read as first paper above will be in force till the next revision of the rates. In the Government letters read as third and fourth papers above directions were issued for the continuance of the seigniorate rates fixed in the Government order read as first paper above till 31..3..1989.

2. In this letters read as 5th paper above the Chief Conservator of Forests has requested that sanction may be accorded for the continuance of the seigniorage rates fixed in the Government order read as 1st paper above for the period from 1.4.1989 to 31.3.1990. He has also requested interalia that the seigniorage rates of timber, Firewood and other Forest Produces may be revised with effect from 1..4..1990 onwards as proposed by him.

3. Government have examined the matter in detail and are pleased to order that the seigniorage rates of Timber, Firewood and other Forest Produces fixed in the Government order read as first paper above will continue till 31..3..1990.

Government are also pleased to order that the seigniorage rates of Timber, Firewood and other Forest Produces. (Forest Produces not coming under the purview of Kerala Forest Produce (Fixation of Selling Price) Act 1978) will be revised for the period from 1..4..1990 to 31..3..1991 as in the Appendix to this Government order.

5. The Chief Conservator of Forests will forward urgently proposals for the revision of the seigniorate rates of the Timber, Firewood and other Forest Produces for the period from 1..4..1991 onwards.
