ORDER

As per Government Order cited 1st and 2nd above, Government had revised the rates of daily wages in respect of different categories such as Clerk, Typist, Chainman, Security Guard, Class IV, Workers in Government Presses, Driver, Pump Operator, Data Entry Operator and Computer Operator/Junior Programmer. Thereafter, vide Government Order 3rd cited, Government had enhanced the rates of daily wage in respect of Drivers only. So many representations have been received in Government for enhancement of daily wages. Since the last revision was done in 2011, except in the case of Drivers, Government felt it necessary to enhance the rate of all categories of daily wage employees.

2. Accordingly after considering the matter in detail, Government are pleased to revise the rates of daily wages in respect of categories mentioned below with effect from 01.10.2014. The rates as below will apply only for full time work. This will not apply to those engaged casually for doing part-time work, like sweeping.
