Re: 1. Correspondence resting with letter No.D.O.C1-49566/74- dated 9-1-1978 from the Chief Conservator of Forests.

ORDER

Justice Balakrishnan Eradi, who was appointed as Commission of Enquiry to enquire into certain allegations against Dr. K.C. Jaiyodi, the then Minister for Finance and Forests, had commented upon the lack of Co-ordination between the different departments in the matter of protection of forest lands and forest wealth. The Commission therefore suggested to have a separate Forest Protection Force in the Department.

Government after considering the suggestion in detail order that a separate force as indicated in Appendix I - for the protection of the forest lands and forest wealth will be created immediately. The posts mentioned in appendix II will be abolished simultaneously from the existing Vested Forest Protection Force.

Sanction is also accorded for the purchase of 7 Jeeps and 13 V.H.P. sets for the use of the Forest Protection Force.

The expenditure will be incurred after observing "New Service Procedure". The Inspector General of Police will take immediate steps to make available the necessary Police Personnel for the above Forest Protection Force.


