ORDER

In the G. O. read above, orders were issued in regard to the implementation of a scheme for the supply of the Public Service Commission application forms, free of cost, to candidates belonging to the Scheduled Castes and Scheduled Tribes, for applying for the posts for which they are qualified. Government are now pleased to order that item (vi) in that G. O. be substituted with the following, namely:—

“(vi) The cost free forms will be supplied from the Public Service Commission Forms Store of the Printing Department to the various District Offices of the Public Service Commission, according to their requirements, for further distribution to the distributing agents mentioned in items (iv) and (v), on indent. But the forms will not be sent by post to the distributing agents concerned. They will have to make their own arrangements to collect the forms from the District Offices of the Public Service Commission. The Heads of Departments concerned will instruct the departmental distributing agents of the cost-free forms to collect the forms from the respective District offices of the Public Service Commission and to take steps for the distribution of the same”.
