**ORDER**

The period of temporary exemption to employees belonging to Scheduled Caste/ Scheduled Tribes from passing all tests (Unified, Special or Departmental) granted in the G.O read as first paper above, was extended from time to time. In the G.O read as second paper above, the exemption was made applicable to promotion tests as well as probation tests with effect from 13<sup>th</sup> April, 1983. It was also ordered that the new entrants in service after 31-12-1985 will not be entitled to any test exemption.

2. The period of temporary exemption extended vide order third paper above, will expire on 31-12-1988. Government after considering the matter in detail are pleased to order that Scheduled Caste/ Scheduled Tribe employees who were in service as on 31-12-1985 will be exempted from passing the tests ( Unified, Special or Departmental ) for a further period of one year from 1-1-1989 to 31-12-1989.
