O R D E R.

The Chief Conservator of Forests in his letter 2nd cited has reported that since there was no space in Trichur Depot to accommodate further arrivals of timber from various coupes of Trichur Divn. The Divl. Forest Officer Timber Sales Dn., perumbavoor had directed the Depot Officer, Trichur to take an addl. plot for stacking timber. Accordingly a plot of 4.27 acres in survey No. 668 and 669 of Ollukkara Village in Trichur District belonging to Mar Adhaislecha Church was taken on rent at Rs. 12-50 per cent per annum for the period from 25-4-'77 to 31-3-'78. It is reported that the rate of rent sanctioned as per the G.O. read as 1st paper above in such case is Rs. 25 per cent per annum against the agreed rate of Rs. 12-50.

2. The Chief Conservator of Forests in his letter 3rd cited has also reported that in addition to the land taken on lease from Mar Adhai Slecha Church other 2 plots belonging to Shri K.Raman Nair, Karapura House in Survey No. 611 extending to 1.96 acres and extent of 2.18 acres of land belonging to Smt. Katherine in Sy.No. 641, 600 of Ollukkara Village were taken on lease from 3-12-77 and 1-2-'78 respectively at the rate of Rs. 25/- per cent per annum. These addl. lands were taken as there was no space for stacking timber coming from Chimay coupes of Palappilly Range in Trichur Divn.

3. The Chief Conservator of Forests has therefore, recommended to Govt. that the action of the Divl. Forest Officer, Timber Sales Division, Perumbavoor in having taken 4.27 acres of land at a rate of Rs. 12-50 per cent per annum from 25-4-'77 to 31-3-1978 may be ratified. He has also recommended that sanction may be accorded for payment of lease rent at the rate of Rs. 25/- per cent per annum to Shri K.Raman Nair, Karapura House and to Smt. P. Katherine.

4. Govt. are pleased to accept the recommendation of the Chief Conservator of Forests and they order accordingly.
