**TOUR OF OFFICERS OUTSIDE THE STATE—ACCOMMODATION IN PRIVATE HOTELS  
AND GUEST HOUSES—REIMBURSEMENT OF—ROOM RENT—REVISED  
ORDERS ISSUED**

**ORDER**

According to the Government orders read State Government Officers touring outside the State are entitled to get reimbursement of room rent when they stay at private hotels and guest houses at the following rates.

- (i) New Delhi, Bombay & Calcutta. Actual room rent paid diminished by one-third daily allowance subject to a maximum of Rs. 100 a day.

For stay in New Delhi the reimbursement is admissible only if accommodation is not available in Kerala House.

- (ii) Other State Capitals Actual room rent paid subject to a maximum of Rs. 50 a day.

The officers are entitled to get daily allowance in accordance with the rules in addition to the benefit of reimbursement of room rent at the rates specified above.

2. Government have reviewed the above orders and it is felt that the rates call for some upward revision in view of the increased cost of accommodation in private hotels in big cities. Government have also decided

to dispense with different methods for calculation of the amount of reimbursement due for the 3 cities of New Delhi, Bombay and Calcutta. Accordingly, Government are pleased to revise the rates of reimbursement of room rent in private hotels and guest houses admissible to State Government Officers for tour outside the State as follows:—

- (i) New Delhi, Bombay and Calcutta Actual rent paid subject to a maximum of Rs. 140 a day, on condition that for stay in New Delhi the reimbursement will be admissible only if accommodation is not available in Kerala House.
- (ii) State Capitals other than New Delhi, Bombay and Calcutta. Actual rent paid subject to a maximum of Rs. 50 a day.

The Officers can draw daily allowance to which they are eligible for under the rules in addition to room rent at the rates specified above.
