Order

As per the G.O. read as first paper above it has been clarified that selection to undergo the Diploma Course in Forestry at the Indian Forest College, Departmental candidates i.e., trained Rangers in Government Service are eligible for relaxation of upper age limit only to a maximum period of five years even if they belong to scheduled Castes/Tribes or Backward Classes.

Government of India have now in their letter read as second paper informed that Rule 10 regarding age in the 'Rules for admission to the Diploma Course' has been since amended as follows with a view to make the rule very clear.

"Directly Recruited Candidate must not be less than 19 Years nor more than 24 Years of age on the first of April of the Year in which they join the training course. In case of departmental Candidate (i.e., trained Rangers in Government Service) the age should not be less than 19 Years nor more than 29 Years on that date. The prescribed upper age limits may be relaxed in the case of Scheduled Castes/Tribes Candidates for both direct recruits and departmental candidates by a period of 5 years. In the case of the candidate belonging to Backward Classes the prescribed Upper age limits may be relaxed in accordance with the rules of the State Government concerned for the Corresponding Service/ posts".

Candidates must produce a certificate of age on joining the College.

In the circumstances Government cancel the orders issued in G.O.Rt.1808/Agri. dated 6.7.1967.
