from the Chief Conservator of Forests.

O R D E R

The Internal Audit Wing of the Forest Department at present consists of one Junior Superintendent and two Upper Division Clerks sanctioned in G.O. read as first paper above. The Chief Conservator of Forests has pointed out that the existing audit staff is inadequate to audit the various institutions in a year. In order to make the check more effective the institutions have necessarily to be audited at least once in a year. The Chief Conservator of Forests has, therefore, submitted proposals for strengthening the Audit Wing in the Department.

2. Government have examined the proposals of the Chief Conservator of Forests and they issue the following orders:-

i) For purposes of audit the Forest Department will be divided into two zones; north and south - each under the charge of an audit party consisting of one Junior Superintendent and two Upper Division Clerks. For the above set up of the Departmental Audit Wing the following additional staff is required:

Junior Superintendent - 1  
Upper Division Clerks - 2

ii) Sanction is, therefore, accorded for the creation of one post of Junior Superintendent (B. 190-300) and two posts of Upper Division Clerks (B. 120-230) temporarily till the end of February 1969.

3. The expenditure on this account will be debited to "70 (a) (1) (iii) - Strengthening of administration."

4. As a result of the formation of the additional audit party sanctioned in this G.O. the work in the Accounts Branch of the Chief Conservator's office will be increased. The Chief Conservator of Forests may appoint additional staff required in the accounts branch by some internal working arrangement.
