**ORDER**

In the G.Os read as first and second papers above, Government issued orders allowing the benefit of a higher grade, with effect from 1-7-1979 to all Non-Gazetted and Gazetted Officers respectively, who remain in the entry grade for 13 years without promotion in the normal course. Detailed instructions for the implementation of the above orders have been issued in the G.O. third cited. As per G.O. read as fourth paper above, a person who entered Government service as a copyist and who has been subsequently promoted/appointed as L.D. Clerk, will be eligible for the higher grade on completion of 13 years of total qualifying service as Copyist/L.D. Clerk.

2. Some of the Heads of Departments have sought clarification whether a person having service in different departments in different posts having indetical scales of pay can be allowed higher grade reckoning the periods of service in all such posts taken together for purpose of computing the 13 years qualifying service (excluding, however, the periods of actual breaks of service, if any)

3. Government have examined the point in detail and are pleased to order that a person who has put in service in more than one post borne on identical scales of pay, in the entry grade will be eligible for the benefit of higher grade, in terms of G.O. read as third paper above, reckoning his total service rendered in all such posts, (excluding, however, the period of actual breaks in service, if any,) provided such services has been reckoned for the grant of normal increments.

4. These orders will have effect from 1-7-1979.
