O R D E R

In the circular 1st read, it was clarified that leave/surrender of earned leave can be granted to an officer after reinstatement but before regularization of the period of suspension, provided, the period of leave/surrender leave thus granted does not exceed the leave earned by the officer by virtue of his service after the date of reinstatement. It was also clarified that if the officer has to his credit earned leave in excess of the period of suspension there is no objection to the grant of earned leave/surrender of earned leave after reserving earned leave equal to the period of suspension.

The Accountant General in his letter 2nd read has requested clarification whether an officer under suspension is entitled to surrender leave salary while under suspension in respect of the leave earned by him prior to the date of suspension. According to Rules 59, Part I, Kerala Service Rules, leave may not be granted to an officer under suspension. So the question of payment of leave salary/surrender leave salary during the period of suspension does not arise. Accordingly, Government are pleased to clarify that an officer under suspension is not entitled to surrender leave salary while under suspension in respect of the leave earned by him prior to the date of suspension.
