ORDER

As per note below Rule 12 (31) of Part I, Kerala Service Rules, where special pay is granted in lieu of a higher time scale of pay, such special pay will count for purposes of fixation of pay on promotion to higher post provided the officer was drawing it continuously for a minimum period of three years on the date promotion. The Accountant General in his letter read above has suggested to issue the following clarification in the regard on the basis of the orders issued by the Government of India.

(1) In cases where the special pay in lieu of higher scale of pay is drawn in the same post for broken periods, the special pay will be treated as pay for the purpose of fixation of pay on promotions to a higher post, provided the total of such broken periods is not less than three years.

(2) In cases where the special pay varies from the time to time during the period of three years, the special pay to be taken for the purpose of fixation in the higher post shall be the one drawn immediately before the date of promotion.

(3) While giving re-fixation of pay under Rule 28A/37(a) Part I, Kerala Service Rules, the special pay in lieu of higher time - scale in the lower post which the officer would have drawn but for the promotion will also be included for the purpose of re-fixation, provided the officer would have officiated in the lower post but for the promotion.
