ORDER

According to rule 1 of the rules for fixation of pay prescribed in Annexure III of the G.O. read above, a period of six months from 1-11-1989 has been allowed to exercise option to change over to the revised scales or to remain in the pre-revised scales of pay. The time so allowed for exercise of options expires on 30-4-1990.

2. Subsequent to the issue of the general pay revision orders read above, number of clarifications/orders on the same have been issued. Government have also received a number of representations from employees seeking permission to exercise revised option as their earlier options are not found to be advantages.

3. Government, in consideration of the above aspects, order that the time limit for the exercise of option in respect of the 1988 pay revision will be extended by four months from 1-5-1990. Government also order that employees who have already exercised options or are deemed to have exercised options and who wish to revise the same will be allowed to exercise revised options within the extended period subject to the condition that refund, if any, on account of revision of option shall be made in lump.

4. Employees retired on or after 1-7-1988 will also be eligible to exercise re-option as ordered in para 3 above.

5. Government make it clear that the above concessions are granted as a special case and that no further extension of time will be granted.
