ORDER

In the Government proceedings read sanction was accorded for the grant of certain concessions to retired officers, in the matter of reckoning emoluments drawn in an officiating capacity of in temporary posts for pension and the rules in the Trivancore Service Regulations and the Cochin Service Regulations were also suitably attended (Vide Article 325A, Travancore Service Rules and Article 217 A, Cochin Service Regulations). By the G.O.read as 6th paper the above concessions were extended upto 31-12-1975.

2. Under Article 487B of the Madras Pension /code also retired officers are allowed certain concessions in the matter of reckoning emoluments drawn in an officiating capacity or in temporary posts for pension. Orginally only these officers who retired from 1-1-1948 to 31-12-1957 were eligible for these concessions. By the G.O. read as sixth paper these concessions were extended upto 31-12-1975.

3. Governments have examined the question of extending the above concessions further and are pleased to extend the concessions in question upto 31-12-1977. in respect of officers government by the above three Service Rules.
