NOTIFICATION

S.R.O NO 519/81 – In exercise of the powers conferred by sub - section(1)
of section 2 of the kerala public service Act , 1968 (19 of 1968) read with section
3 thereof , the Government of kerala hereby make the following rules further to
amend the kerala Service Rules namely ;-

1. (1) these rules may be called the kerala Service (Amendment) Rules, 1981.
(2) They shall come into force at once.

2. In part 111 of the Kerala service Rules , in Appendix x in sub – rule (2)
of rule 5 under part A for the third and fourth sentences , the following sentence ,
shall be substituted namely –

“ The date of effect for the reduction in pension shall be the 1st of the month
in which the commuted value is drawn by the pensioner or the 1st of the 4th month
of the issue of authorization by the Accountant General including the month of
issue of authorization whichever is earlier

Explanatory NOTE

Government of India in the O.M read above have clarified that in the case of
Central Government employees the reduction in the amount of pension on account of
commutation shall become operative from the date of receipt of the commuted
value of pension by the pensioner or three months after the issue of the authority
asking the pensioner to collect the commuted value of pension by the Accounts
officer , which ever is earlier . Government have examined the question of extending
the benefit to the state Government employees and are pleased to issue the above
notification .
