In the Government Order read above one post each of Assistant Conservator of Forests has been sanctioned in the Forest Divisions of Waynad , Kozhikode, Nilambur, Trichur, Malayattur, Munnar, Ranni, Konni and Trivandrum. Consequent to this it has become necessary to allot specific duties and functions to the Assistant Conservators of Forest attached to Territorial Divisions. In the letter read as second paper above the chief conservator of Forests has forwarded proposal in this regard. Government after having examined the proposal prescribe the following duties and functions for the Assistant conservators of Forests attached to the Territorial Divisions:-

- I (a) Regeneration Works.
Murscry- Planting – Maintenance of Plantation upto first three years.
- (b) Thinning works
Thinnings up to collection and stocking of thinned materials .

In the above cases the duties of the Assistant Conservator of Forests included related matters like sanctioning of estimates, checking of works in the field, passing of vouchers and sanctioning advance for the above works. Cheques will be issued by the Divisional Forest Officer who will be preparing and sending the monthly accounts to Accountant General And Superior Officers.

In Divisions where the work load of Assistant Conservator of Forests is heavy the Conservator of Forests concerned will make suitable apportionment of the above works between Assistant Conservator of Forests and Divisional Forests Officers.

II. Any other works assigned by the Conservator of Forests concerned.

Government also order that the Assistant Conservators of Forests attached to the Territorial Division should work independently of the Divisional Forest Officers and should be under the direct supervision of the concerned Conservators of Forests so far as the work assigned to them are concerned.
