**ORDER**

As per the G.O cited the benefits of liberalized pension formula were extended to pre 31-3-1979 pensioners by granting an increase of 1/3<sup>rd</sup> of the original pension in respect of retirements before 1-7-1978 . It is also ordered in para 6 there in that an increase of 7/33 of the basis of pension will be allowed in the case of those who retired between 1-7-1978 and 31-7-1979 , In the case of retirements between 1-7-1978 and 31-3-1979 pension has been allowed for a maximum qualifying service up to 33 years whereas the maximum qualifying service pension was 30 years in respect of retirements prior to 1-8-1978 and after 31-3-1979 , so such among the persons retired between 1-7-1978 and 31-3-1979 will not get the benefit or full pension . This anomaly has been brought to the notice of Government

Government have examined the matter in detail and are pleased to order that in the case of those who have qualifying service of 32 years , 31 years and 30 years and below and retired between 1-7-1978 and 31-3-1979 an increase of 8/32 , 9/31 and 10/30 respectively of basic pension will be allowed in the place of the increase of 7/33<sup>rd</sup> mentioned in para 6 of the Go cited. The increase will be allowed by the treasury officer concerned on the basis of individual requires for revision supported by sufficient proof as to the qualifying service . In the case of any doubts in qualifying service. In the Accountant General should be consulted by the Treasury officer.
