NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Kerala hereby makes the following amendment to the Kerala Service Rules, namely:-

AMENDMENT

C.S. No. 29/62 Dated 19-10-1962

In part 1 of the said rules, in rule 93, the following shall be added as Note 3 namely:-

“Note: 3. In order to allow the benefit under Not 2, the authority which is competent to fill the specified post in respect of which the benefit is proposed to be granted should furnish a certificate in the form given below.

The production of certificate will not be necessary, when

- (i) a Government servant has continuously officiated in a gazetted post for more than 3 years and has not availed o any leave;
- (ii) a gazetted Government servant has availed of earned leave for which a certificate under the Note to rule 33 © has been furnished to the Accounts Officer and he has been allowed increment without its being postponed; and
- (iii) a gazetted Government servant has officiated in a higher post for which a certificate of continued officiation in the lower post but for appointment to the higher post has been furnished to the Audit Office and the Officer has been allowed to count the period for increment in the lower post.
