ORDER

According to rule 13AA of the General Rules, notwithstanding anything contained in the said rules, the Government may by order, exempt for a specified period, any member or members belonging to a Scheduled Caste or Scheduled Tribe and already in service from passing the tests referred to in rule 13 or rule 13a of the said rules. By invoking this power, Government issued orders in the G.O. read as first paper above, exempting the Scheduled Castes and Scheduled Tribes in services from passing all tests (Unified and special or Departmental tests) for a period of two years from 13-1-1972. By the G.Os read as second, third and fourth papers above, the above period of temporary exemption has been extended for one year from the date on which the results of the tests last conducted by the Public Services Commission were published.

The question whether promotions given to Scheduled Castes and Scheduled Tribes by virtue of temporary exemption from passing Departmental Tests can be regularized with effect from the date of first promotion if the person concerned passes the tests during the period of exemption, has been examined by Government in details. They are pleased to order that the promotions given to members of Scheduled Castes and Scheduled Tribes in service by virtue of the temporary exemption granted in the G.Os read above from passing Departmental tests mentioned therein be regularized with effect from the dates of their first promotion on provisional basis, if the persons concerned pass the required tests within the period of temporary exemption.
