## ORDER

A Large number of staffin certain lower categories have been rendered surplus in the Land Reforms Wing of the Land Revenue Department as on 1.3.1978 and 1.9.1978 due to the reconstitution/abolition of certain Land Tribunals. They have been absorbed in other Departments in comparable posts with a view to avoid large scale retrenchment.

- 2. Now it has been proposed that the staff so absorbed in other Departments may be reabsorbed in the Revenue Department according to the availability of vacancies.
- 3. The Government have carefully considered the proposal. It is now known that there will be no further surplus village men consequent on the latest periodical review of staff position in the Land Reforms and that there are some vacancies of Villagemen in various Districts.
- 4. In the circumstances and as a first step of re-absorption of the surplus staffin the Revenue Department it is ordered that the Villagemen deployed in other Departments/District Revenue Establishment will be re-absorbed in the respective District Revenue Establishments from where they had been rendered surplus, by withdrawing them from the Departments to which they been allotted for absorption
- 5. The reabsorption will be done strictly according to seniority and subject to the willingness of the persons concerned for such reabsorption.
- 6. The District Collectors concerned will assess the availability of vacancies of villagemen and address the concerned Head of the Departments in which the persons have been absorbed, for the withdrawal of persons for reabsorpotion in the their District Establishment, while this is being done it should be ensured that such persons reabsorbed will not become surplus again.
- 7. The Heads of Departments are requested to relieve the persons on receipt of re-absorption orders from the respective District Collectors if the persons are willing to go back to Revenue Department, without waiting for substitute arrangement.

- 8. No vacancy in the District Revenue Establishments in the categories in which surplus have emerged. And absorbed in the other Department should be reported to the P S C till the staff who are willing for reabsorption are taken back to the Revenue Establishment.
- 9. The question of reabsorption of other categories of staff in the Revenue Department is under consideration and orders will be issued separately.
